The ERMHS assessment process has been a focal point of discussion in California school districts over the past several years. Developing a comprehensive and defensible assessment requires accurate data collection, interviews, assessment measures and methodical recommendations. Whether your district utilizes a multidisciplinary approach or a stand-alone/single disciplinary report, this training will equip participants to take into consideration the student's social/emotional/behavioral needs. Synthesizing and incorporating existing reports will help providers generate recommended relevant accommodations, ERMHS supports and school placement options. The planning, coordination, and organizational methods will further define best practices for Riverside County SELPA school districts.
