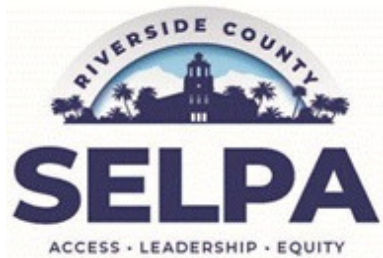

- Explain the principles of MI, including expressing empathy, developing discrepancy, rolling with resistance, and supporting self-efficacy.
- Identify change talk vs. sustain talk and recognize their importance in behavior change.
- Understand the OARS communication skills: Open questions, Affirmations, Reflective listening, and Summarizing.
- Identify the Deliverance of Motivational Interviewing in the School Setting.
- Demonstrate respect for diverse motivations and readiness to change.
