7. SELPA Business

7.1 SELPA Personnel Updates

Jeremy has resigned as the RC SELPA ERMHS Coordinator to accept a position as an ERMHS Coordinator at PUHSD. RC SELPA is working with Human Resources to recruit for the position.

7.2 ERMHS Funding - 2023-24 School Year

The Governance Council took action on how RC SELPA will move forward with the ERMHS funding structure. We will keep the current structure. The change will take place next year. Will need to develop the MOU language and update the language of the Local Plan. The Local Plan is up for renewal next school year.

7.3 Legislative and Fiscal Updates

Last month priorities were discussed at the state SELPA and Coalition. State priorities will include staffing shortages, inclusion, building on SB 1113 and changing the eligibility title of ED.

There are rumors of the possibility of disbanding SELPAs.

7.4 DRDP Update

Received information this week regarding 4-year-old Transitional Kinder students with disabilities. DR Access will be postponing that requirement. Asking CDE for official information.

7.5 Compliance and Improvement Monitoring

a. Small Schools Monitoring

Met last Wednesday with the representatives of the 4 small schools. Reviewed the policy and procedures. The next step is a student file review.

b. IEP Implementation Monitoring

Conversation around different services and how we would monitor. A lot has landed on the service tracker. There will be a presentation at 11a.m. today. There has been talk of having teachers certify. This will be a general education issue as well as a SpEd issue.

c. CIM Plans

Targeted and intensive monitoring have been submitted into the stepwell system or have been granted an extension from their FMTA. Intensive level monitoring is a 3-year plan. APR should follow subsequent years with monitoring under way. Technical assistance providers will continue to work with you as you continue to implement. Additional information on monitoring will come out from CDE.

New APR will be released in February for the next round of monitoring.

8. Riverside COE Report

8.1 2023-2024 Program Transfer Final Notification

No take backs for the 2023-24 school year. RCOE will continue to work with LEAs on program guides. Just prepared a program guide for Jurupa's Superintendents and the cabinet of the programs offered. The program guide will include the hours of each program.

Casaundra has resigned from RCOE to a new role at Perris Union High SD as the Director of Equity and Inclusion. Casaundra's tentative start date is January 6th. The RCOE Director position closes on November 20th. Please remind your team of the referral process on page 5 and ensure the procedure is being followed.

Randy and Dr. Sorter are at SEACO. The networking meeting will be held on Wednesday to present on alternative diploma pathways. CDE is working to have something put together by January. Anticipate about 2 years to put together.
