**7. SELPA Business**

**7.1 Legislative and Fiscal Updates**

**a. Governor's Budget**

COLA will be applied to SpEd funding. The single district SELPA moratorium has been extended to 2026. There will be a change in terms of posting SpEd documents. Local plans will be required to be posted on the CDE website.

The cap of the amount of money that SELPA can keep at the SELPA level for the 2023-24 school year will be allocated the same as the year prior. No allowance for declining ADA. RC SELP maintains about 1% of the total base dollars as opposed to the \$300 million we push through to LEAs.

**b. Bill Introductions**

AB 87 (Quirk-Silva) would change Ed Code to allow parents to record 504 meetings. This will require extensive training for those holding 504 meetings.

SB 354 carryover of SB 13 (Ochoa-Bogh) inclusion bill. Introduced language around inclusive practices.

The last bill does not have an author. Hoping Eduardo-Garcia will pick up the bill around SELPA governance. Specific to supporting Differentiated Assistance and the County Offices. Recommend being pushed up to 2025.

**7.2 Compliance and Improvement Monitoring**

**a. Small Schools Monitoring**

Four LEAs are participating in small school monitoring. Plans are due in January. Waiting on CDE on another component due date.

**b. IEP Implementation Monitoring**

February 16th CDE will host a webinar on the mechanisms to collect data this spring. The window is open from February-April 2023. Record review of students that receive 90% of services. CDE does not mandate how districts collect data. IDEA is clear that it must implement the service on IEP. Attendance logs can be used.

**c. Compliance and Implementation Monitoring and Differentiated Assistance**

Those LEAs in intensive monitoring will continue implementation and work with a TA provider.

Targeted monitoring will most likely be in the group of notified of the next step. In March how you performed on all indicator SPP levels will be working through the Spring /Summer to submit a plan.

RC SELPA continues monthly collaboration with the County Office. More districts eligible for DA this year. If you don't know if you are eligible for DA Leah will help to determine.

**7.3 Alternative Pathway to Diploma**

State SELPA has a workgroup that continues to closely monitor the Alternative Pathway to Diploma. State SELPA is hosting a legal series.
