Discussion and Information Items

8. Governor's Budget

Continue to wait for the actual budget. SpEd received \$500 million dollars, which increases the SELPA base rate. This will allow all SELPAs throughout the state to equalize. ERMHS funding (State and Federal) will be allocated to LEAs beginning in the 2023-24 school year. The SELPA ERMHS team does NPS/RTC monitoring. As the governor's budget stands SELPA will have to possibly begin a fee for service to maintain the ERMHS team at the SELPA level. The ERMHS fed dollars in the past were exhausted and had to have a 50/50 split for NPS/RTC students. This year SELPA was able to cover 100% of NPS/RTC.

9. Special Education Compliance Monitoring and Accountability in 2021-2022

- a. Targeted and Intensive Monitoring

Currently have four LEAs in Disproportionality, four in Intensive Monitoring and about five in Targeted. RC SELPA is working directly with all of our LEAs. Improvement Facilitator's are working on compliance monitoring. Plan is due to the state by November 1. There will be a shift in how CDE is doing the monitoring this year. Those in Sig Dis are working with CDE on sustainable improvement. We continue to watch case studies. The state is revamping the disproportionality process.

Continue to work with NPS on their monitoring. Bright Futures had 59 RC SELPA students who have all been moved utilizing ESY. Other NPS partners have been amazing. BFA is appealing revaccination.

Childhelp-CDE did a follow-up unannounced visit. Following up on a swimming pool concern. The swimming pool was closed till October. Nobody on site is water certified. Students were swimming unattended. CDE is determining how they will handle that. 17 students attending Childhelp.

Recruiting for an Account Technician position. Tech is responsible for reconciling IEP/ISA's . Admin assistant is currently doing this job. RC SELPA Accountant resigned. She is working diligently to close the books. Will work with Bridget (former Accountant) to close the year.
