7.7. Legislative and Fiscal Updates

COLA came in above 6%. COLA will also be applied to Non-Public Schools rates. ERMHS dollars-State SELPA of California is advocating for funds to not be sent directly to LEAs. ERMHS funding (State and Federal) will be allocated to SELPAs for the 2022-23 year but will be allocated to LEAs beginning in the 2023-24 school year. Discussion of ERMHS funds will be discussed at the next Governance Council meeting. Fee for service option was discussed as well as federal dollars to come back to SELPA. Any ERMHS professional development would have a fee. Impacts to service delivery model; LEAs would be responsible for RTC/NPS monitoring. Districts will need to hold their own Master Contracts for vendors. The Allocation Plan language would need to be revised. SELPA Finance is on Monday. RC SELPA Executive Director will ask Bridget to do an analysis for SELPA Finance.

SB 1113- Ochoa-Bough's bill around inclusive education. A two-year bill is moving forward to the governor's desk.

SB 692- Bill to add LCAP data to the dashboard. There will be a link on the dashboard with data.

7.8. Alternative Dispute and Learning Recovery Dollars

In the coming weeks LEAs will be asked by the state to identify what they have spent Alternative Dispute and Learning Recovery Dollars on, giving LEAs/SELPAs to revise their plan. Dates pending that funds need to be encumbered by.

7.9. Independent Study

Priority of the state legislative committee. Seeking to clean up the bill language. Cynthia Vargas will join RC SELPA at our first Lunch and Learn.

7.10. Alternative Pathways Diploma

Information sought out from CDE. Option that is available in federal law. California has started a workgroup.

7.11. Compliance and Improvement Monitoring

Intensive monitoring plans are due in the Stepwell System by November 1. If support is needed, reach out to SIL/SIP/CDE. RC SELPA Coordinators are available as assigned to LEAs. Conversations last Spring about service delivery. High probability districts will have to certify in service delivery. Many LEAs have systems in place for Medi-Cal billing. Take attendance-label as SAI delivery. Ensure that services are provided.
