Children's Case Management provides screening of referrals for minors needing intensive residential treatment, as well as case consultation, case management and interagency coordination. These services are for minors at high risk for, or in need of, residential placement. Intensive adolescent and children's residential services are available via contract through this program per referral from Placement Screening Committees and Individualized Educational Program (IEP) Teams.
